Year in Review



This past year was certainly one for the history books. When everything closed down and people stayed home, we remained open. We knew our services were needed more than ever before, which is evident in the numbers.

Compared to pre-pandemic, almost all our programs experienced an increase in the number of individuals served, ranging from 24% to 167%. That highest increase came in our Summer Feeding program that provides meals to children when they aren't in school.

A day rarely goes by without someone asking us what the need looks like now. Once again, we can turn to the numbers. Before COVID-19, three out of four individuals used our Emergency Food Box program no more than two times. This past year that number changed to one in two individuals, which tells us that people needed help longer during the pandemic. We met countless individuals through our programs whose lives were turned upside down these last 18 months. Each story was unique, yet they all held a common theme.

- Allyson's husband was without work for months after being furloughed from his oil and gas job. She drove 30

minutes with three of her four kids in a borrowed truck to get help with food.

- Talia told her first-grade teacher that she hadn't had breakfast in a week because there was no food at home. The first time she received food through the Backpack Program, she cried tears of joy.
- Hector's health was getting worse because his medication needed to be taken with food which he didn't always have. One month after signing up for our Senior Feeding Program, he called to tell us his health has never been better.

We were able to serve Allyson, Talia, and Hector because of the incredible support of our community. Since the end of March 2020, we have asked a lot of our community and everyone who answered the call did not go unnoticed. Food donors of all sizes gave beyond their normal contributions, countless financial donors gave additional gifts, and volunteers began signing up for multiple shifts a week. **Each one of our supporters went above and beyond because they knew that only together we would overcome this difficult time.**

Weld Food Bank Programs



Kids Cafe

An after-school program where we provide nutritional, prepared meals and snacks for undernourished children. **Last school year we served 84,807 meals to children. Up 47% compared to pre-pandemic.**



Backpack Program

Provides food for children who are at risk for hunger over the weekend. **This past year, with the help of our agency partners, we distributed 75,364 backpacks. Up 74% compared to pre-pandemic.**



Summer Feeding

Makes hot lunches accessible to children over the summer months when free and reduced school meals are not available. **Last summer, we served 97,826 meals to kids. Up 167% compared to pre-pandemic.**



School Food Pantries

In select schools throughout Weld County. Every teacher has access to the food for times when students come to school hungry. **Last year, the School Food Pantries were accessed over 600 times.**



Emergency Food Boxes

A box of basic food staples available to any resident of Weld County who needs help during a difficult time. **Last year, we distributed 35,912 Emergency Food Boxes. Up 25% compared to pre-pandemic.**



Mobile Food Pantry

A refrigerated beverage truck delivering fresh produce, dairy products, meat, bakery, and dry goods directly to hungry people in high-need areas. **Our Mobile Food Pantry distributed 3 million pounds of food last year. Up 15% compared to pre-pandemic.**



Senior Feeding Program

For seniors over 60 years of age. The program ensures that seniors get the basic nutrition necessary for good health. **Last year, we distributed 28,459 nutritional food packages to seniors.**



Farms to Families

Launched in June 2021. Through a custom-built truck, **this program brings healthy perishable foods to smaller sites** such as low-income senior living centers, our Child Feeding sites, and select nonprofit partner agencies.



Nonprofit Agency Partners

We work closely with various other nonprofit agency partners throughout Weld County. **Last year, the food bank worked with 75 different nonprofit agencies, saving them \$2.4 million in food costs. Up 29% compared to pre-pandemic.**
